Emergency Care Plan Booklet

This Emergency Care Plan Booklet provides Emergency Care Plans for specific health conditions.

Teachers may print the entire ECP Booklet or only specific student’s health conditions in class. Student’s health conditions are confidential and, on a need, to know basis. Please keep secure and carry the Emergency Care Plan Booklet and the Student Health Condition List on all school emergency drills.

- We ask that teachers familiarize themselves with the ECPs that are applicable to students’ health condition/s in their class. Ask privately:
 1. If the student uses emergency medication/s
 2. If the student keeps emergency medication/s with them
 3. If the student keeps emergency medication/s in the schools’ clinic
- Fill out the Student Health Condition List. Print out as many as needed or one per class period
- Leave the Student Health Condition List and ECPs pertinent to current health conditions in the substitute teacher folders in a secure location
- Ask the school nurse to meet in order to answer any questions on student’s health condition or to provide training on emergency medication/s

An **Emergency Care Plan** is a plan that gives specific steps for school staff to take when a student has a medical emergency. The plan contains a short definition of the condition, signs and symptoms of the health condition that are emergent and a written step-by-step instruction that outlines what school staff should do for that emergency. Skyward provides information regarding the student’s medical condition and parental/guardian’s contact information.

TO VIEW GRADEBOOK ALERTS:

Clicking on the “**Red Cross**”:
Informs of Health Condition/s a student may have






Clicking on the “**Red Exclamation Point**”:
Informs of a student’s Critical Alert Information

*If a student has Critical Alert Information their name should be red in the gradebook.

Hover over or click on any color box shown in “Roster or Attendance” for the following information.

BLURBS:

Hover over any blurb  to the right of the student’s name to view Critical Alert Information. The  to the right of the student’s name gives info that may impact classroom learning in some way.

768.13 Good Samaritan Act; immunity from civil liability.

(1) This act shall be known and cited as the “Good Samaritan Act.”

(2)(a) Any person, including those licensed to practice medicine, who gratuitously and in good faith renders emergency care or treatment either in direct response to emergency situations related to and arising out of a public health emergency declared pursuant to s. 381.00315, a state of emergency which has been declared pursuant to s. 252.36 or at the scene of an emergency outside of a hospital, doctor’s office, or other place having proper medical equipment, without objection of the injured victim or victims thereof, shall not be held liable for any civil damages as a result of such care or treatment or as a result of any act or failure to act in providing or arranging further medical treatment where the person acts as an ordinary reasonably prudent person would have acted under the same or similar circumstances.
