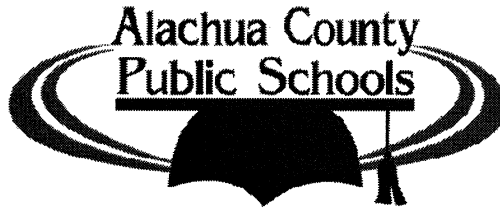

ADDENDUM NO. 1

Answers to questions posed by a prospective Offeror are provided as follows:

- Q: I was looking at the RFP for Cellular Telecommunications and Data Services and was wondering if you could confirm that the current contract for this service. According to your website, a contract with Verizon Wireless expires in June 2010. Does that contract coincide with RFP 10-08, or is there another existing contract? If the Verizon contract does coincide with this RFP, are you able to tell me the value of that contract?
- A: SBAC’s current contract with Verizon Wireless, which is based on State of Florida Contract #725-330-05-1, expires June 30th, 2010. It is anticipated that a new contract, resulting from RFP #10-08, will be awarded sometime in January 2010, but services under the new contract will not begin until July 1st, 2010. The District pays \$.054 per minute for cellular service and \$46.61 per month for each data air card (unlimited data). Please refer to page 15 of the RFP, section titled **“ESTIMATED QUANTITIES**, for additional information.

ALL OTHER TERMS, CONDITIONS, AND PROVISIONS OF THE RFP DOCUMENT REMAIN UNCHANGED AND IN FULL FORCE AND EFFECT.
