- 2. FISH plans for each site attached.
- 3. Q: Please specify the number and type/grade of classrooms at each location.
 - A: See attached FISH Floor Plans 7A and 7B for Littlewood.
- 4. Q: Will items from each room be going to a specific room when relocated?
 - A: Yes. FISH numbers will have a from and a to number for each phase of the move (Swing to WMS; LES to swing).
- 5. Q: Are cubbies and white boards being relocated?
 - A: No. Nothing fastened to the walls to be relocated unless specifically indicated.
- 6. O: Move start date?
 - A: June 4th. Begins with the relocation of admin areas.
- 7. Q: Packing & unpacking by bidder?
 - A: No, unless specifically indicated. All packing and unpacking of totes/boxes to be performed by owner.
- 8. Q: Food Service Scope?
 - A: No food service is included in this move.
- 9. Q: Computers and projectors to be relocated by bidder?

13. Q: Are all goods going to the same location(s)?

A: The swing school goods (totes and furniture) will be going up the hill to the permanent Westwood Middle School site. The Littlewood goods (totes and furniture) will be going across the street to the swing school site. The exception for the Littlewood to swing school move is the 3rd through 5th grade furniture; the exception for the swing school to Westwood move is the excess intermediate furniture (being removed to make room for the K-2nd grade furniture). These goods (along with the fire extinguishers from Littlewood) will go to our Sivia Center located at 3700 NE 53rd Avenue.

- 14. Q: Littlewood piano, stage, and cart-mounted tv's being relocated to swing school?
 - A: Yes.
- 15. Q: Is janitorial equipment, shelving, and supplies being relocated by Bidder?
 - A: Owner to relocate.
- 16. Q: What is to be done with surplus goods?

A: Items at Littlewood are the responsibility of the General Contractor redeveloping the site. Items at The Transition school are the reasonability of SBAC personnel.

- 17. Q: Kids outdoor toys to be included?
 - A: Yes. Sent to The Sivia Center located @ 3700 NE 53rd Avenue Gainesville, FL 32609
- 18. O: Are pullout or specialty classrooms also getting five totes?
 - A: Yes.
- 19. O: Library books getting moved?
 - A: Yes. All books will be packed and ready for relocation.
- 20. Q: Computer lab tables to be relocated?

- A: Yes. Computer tables from Littlewood are to be sent to The Sivia Center located @ 3700 NE 53rd Avenue Gainesville, FL 32609
- 21. Q: How many totes for teacher "maker space", and does the equipment get moved?
 - A: 25 totes. All equipment is being moved.
- 22. Q: Is the media center furniture being moved?
 - A: No.
- 23. Q: How many book boxes (approximately)?
 - A: Approximately 50 library book boxes from Littlewood to Transition School and 50 library book boxes from the Transition School to Westwood.
- 24. Q: Bidder to dispose of leftover goods?
 - A: Not in scope.
- 25. Q: Is the art room included?
 - A: Yes. Provide art 25 totes. Tables and stools to be relocated. Art carts to be shrink wrapped and relocated.

 - A: Filing cabinets are to be shrink wrapped and relocated. Approximately 80 file cabinets are to be relocated from Littlewood and approximately 20 from Transition School

 - A: 5 totes.
- 29. Q: What from the Robotics Lab is being relocated?
 - A: Metal shelving, metal bin hangers, totes.
