  - c. **FASC (Florida Association of Student Council) State Conference in Orlando-** Feb. 21-24 with lodging and registration- not to exceed \$7,000. A. Gandy motioned to approve. W. Rosche second the motion. The motion passed unanimously.
  - d. **AP Testing Facility-** Rental of facility at Alachua County Sports & Recreation Center@Celebration Pointe. \$600/day for 10 days = \$6,000. D. Boykin motioned to approve. A.Peckwood second the motion. The motion passed unanimously.
- C. SRP Bonus Funding Language-**
- a. Award equal, non- recurring bonuses to instructional and non-instructional staff who were here last year and returned this year and are currently employed at Buchholz at the time of the vote. This should be pro-rated (.80=80%...) based on the percentage of time an individual works. D. Boykin motioned to approve. E. Thomas second the motion. The motion passed unanimously.
