- Volunteer in my child's classroom as my schedule permits.
- Stay informed about my child's education.
- **Attend parent/teacher conferences when they are scheduled.**
- **Keep the school informed of any changes in my address, telephone numbers (home, business, and cell phone), and contact persons.**
- Communicate with the teacher and/or administrator when I have a concern.
- **Attend at least one Parent Involvement Activity sponsored by the school during the school year, (i.e., Annual Meeting, Open House, Reading Enrichment, and Math Enrichment.)**
